26. Let  $E = E_0 \sin \omega t$  be the alternating emf ...(1)

$$V = \frac{q}{C} = E_0 \sin \omega t$$

$$q = CE_0 \sin \omega t$$

$$I = \frac{dq}{dt} = \frac{d}{dt} (CE_0 \sin \omega t) \quad 1$$

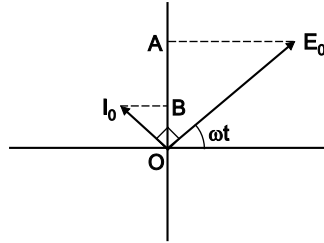
$$= \frac{E_0}{1/\omega C} \sin (\omega t + \pi/2)$$

The current will be maximum if  $\sin (\omega t + \pi/2) = 1$

$$I = I_0 = \frac{E_0}{1/\omega C}$$

$$\therefore I = I_0 \sin(\omega t + \pi/2) \quad \dots(2) \quad 1$$

It shows alternating current leads by  $\pi/2$  to the alternating voltage.



$$OA = E = E_0 \sin \omega t$$

$$OB = I = I_0 \sin(\omega t + \pi/2) \quad 1$$

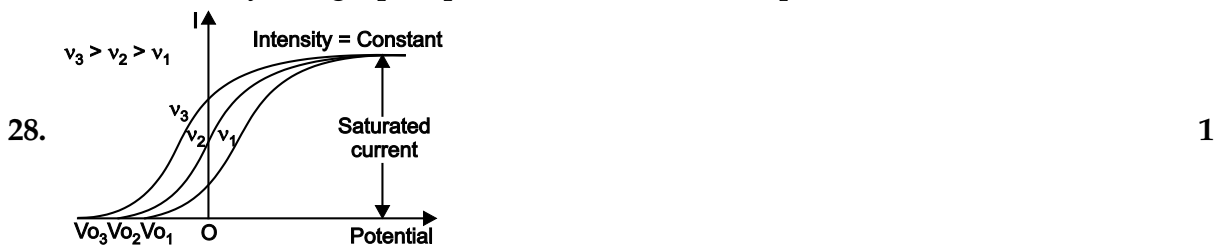
27. Current sensitivity is deflection produced in galvanometer when unit current is passed through it.

$$I_s = \frac{\theta}{I} \quad 1$$

Voltage sensitivity is the deflection produced in galvanometer when unit potential difference is applied across it.

$$V_s = \frac{\theta}{V} = \frac{I_s}{R} \quad 1$$

Sensitivity of galvanometer can be increased by decreasing the twisting constant ( $k$ ). It can be done by using a phosphor-bronze wire for suspension. 1



\* If we take radiations of different frequencies and same intensity then saturated current is same for all radiations but their stopping potential is different.

\* Greater is the frequency of incident radiation, higher is the value of kinetic energy of photoelectron and hence more will be the stopping potential. 2

29. Let

$$y = \sin \omega t \cdot R \cos \theta + \cos \omega t \cdot R \sin \theta$$

$$= R [\sin (\omega t + \theta)]$$

$R =$  amplitude of resultant wave

Sq. and adding (1) and (2), we get

$$R = \sqrt{a^2 + b^2 + 2ab \cos \phi} \quad 1$$

### For constructive interference

$$\cos \phi = \max = +1$$

$$\therefore \phi = 0, 2\pi, 4\pi, \dots$$

i.e.  $\boxed{\phi = 2n\pi}$  where  $n = 0, 1, 2, \dots$

### For destructive interference

$$\cos \phi = \min = -1$$

$$\therefore \phi = \pi, 3\pi, 5\pi, \dots$$

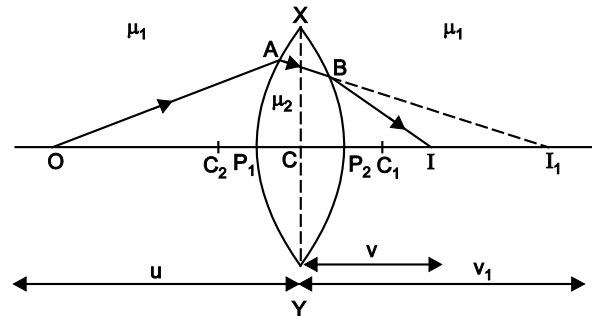
$$\therefore \boxed{\phi = (2n - 1)\pi}$$
 where  $n = 1, 2, 3, \dots$  1

OR

Consider a pt. object  $O$  lying on the principal axis of the lens.

If the lens material were continuous and there were no second surface  $XP_2Y$ .

Therefore  $I_1$  is real image of  $O$  after refraction at  $XP_1Y$ .



$$\therefore \frac{\mu_1}{-u} + \frac{\mu_2}{v_1} = \frac{\mu_2 - \mu_1}{R} \quad \dots(1) \quad 1$$

Actually, the lens material is not continuous. For refraction at  $XP_2Y$ , we take  $I_1$  as a virtual object whose real image is formed at  $I$ .

$$\therefore \frac{\mu_2}{-v_1} + \frac{\mu_1}{v} = \frac{\mu_1 - \mu_2}{R_2} = -\frac{(\mu_2 - \mu_1)}{R_2} \quad \dots(2) \quad 1$$

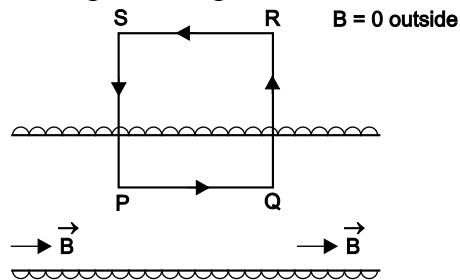

## SECTION E

33. **Huygen's Principle:** Acc. to Huygen's principle  
(i) Every point on primary wave front acts as fresh source of disturbance which travel in all direction with velocity of light and called as secondary wavelets.1  
(ii) Surface obtained by joining secondary wavelets tangentially in forward direction called secondary wavefront. 1

### Refraction of plane wavefront

If  $c_1$  is the speed of light in rarer medium and  $c_2$  is speed of light in denser medium then  $\mu = \frac{c_1}{c_2} \dots(1)$

$AB$  is a plane wavefront incident on  $XY$ . Acc. to Huygen's principle, every pt. on  $AB$  is a source of secondary wavelets.

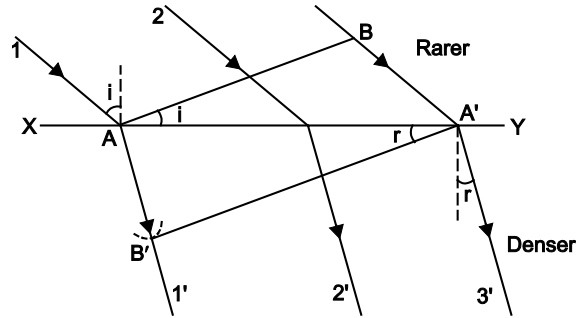
Let secondary wavelets from  $B$  strike  $XY$  at  $A'$  in  $t$ -seconds.

$$\therefore BA' = c_1 \times t \quad \dots(2) \quad 1$$

Taking  $c_2 \times t$  as radius draw an arc at  $B'$  with  $A$  as a centre.

$A'B'$  is secondary wavefront.

$$\therefore AB' = c_2 \times t \quad \dots(3) \quad 1$$



In  $\triangle AA'B$   $\sin i = \frac{BA'}{AA'} = \frac{c_1 \times t}{AA'}$

In  $\triangle AA'B'$   $\sin r = \frac{AB'}{AA'} = \frac{c_2 \times t}{AA'}$

Divide  $\frac{\sin i}{\sin r} = \frac{c_1}{c_2} = \mu$

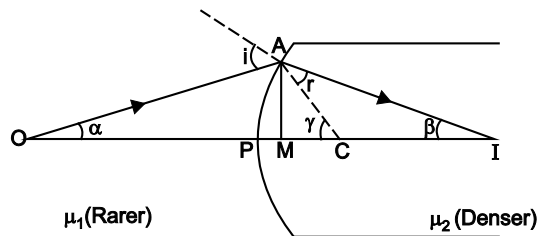
or  $\mu = \frac{\sin i}{\sin r}$  1

It is clear that incident rays, normal and refracted rays all lie in the same plane.

OR

Refraction of light is the phenomenon of change in path of light, when it goes from one medium to another. 1

### Refraction at convex spherical refracting surface



From  $A$  draw normal  $AM \perp OI$ .

$$i = \alpha + \gamma \quad \dots(1)$$

$$\gamma = r + \beta \Rightarrow r = \gamma - \beta \quad \dots(2)$$

Apply Snell's law  $\frac{\sin i}{\sin r} = \frac{\mu_2}{\mu_1}$  1



$$\approx \frac{i}{r} = \frac{\mu_2}{\mu_1}$$

$$i \mu_1 = r \mu_2$$

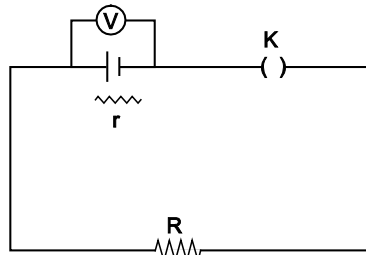

34. Internal resistance of a cell is the resistance offered by the electrolyte and electrodes of a cell. 1

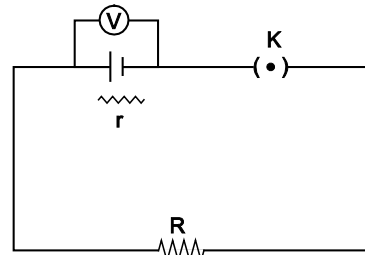
It depends upon nature of electrodes and electrolyte, distance between the electrodes and area of electrodes immersed in the electrolyte. 1

#### Expression for internal resistance

A cell of emf  $E$  and internal resistance ( $r$ ) is connected to external resistance ( $R$ ) with one way key as shown in figure.



(Open ckt.)



(Closed ckt.)

1

When ckt. is open *i.e.*, no current is flowing, then reading of voltmeter is equal to emf of cell.

When key is closed  $I = \frac{E}{R + r}$

Reading of voltmeter is equal to terminal potential difference.

$$\therefore V = E - Ir \quad 1$$

Also  $V = IR = \frac{E}{(R + r)} R$

$$\therefore R + r = \frac{E}{V}R \Rightarrow r = \left(\frac{E}{V} - 1\right)R \quad \mathbf{1}$$

OR

Drift velocity is the average velocity with which free electrons are drifted towards +ve end of conductor under the influence of external electric field.  $\mathbf{1}$

If  $\vec{u}_1, \vec{u}_2, \vec{u}_3, \dots, \vec{u}_n$  be the thermal velocities of  $n$  electrons in a metal.

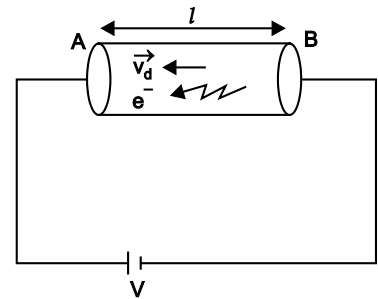
$$\vec{u}_{av} = \frac{\vec{u}_1 + \vec{u}_2 + \vec{u}_3 + \dots + \vec{u}_n}{n} = 0 \quad \mathbf{1}$$

Electric field  $E = \frac{V}{l}$

Force on electron =  $F$

$$F = -e\vec{E} = ma$$

$$\Rightarrow \vec{a} = \frac{-e\vec{E}}{m}$$

$$\therefore \vec{v}_d = \frac{\vec{v}_1 + \vec{v}_2 + \dots + \vec{v}_n}{n}$$

$$= 0 + \vec{a}\tau$$

where  $\tau =$  Av. relaxation time

$$\vec{v}_d = \frac{-e\vec{E}\tau}{m} \quad \mathbf{1}$$

-ve sign shows that drift velocity is opposite to electric field.

**Relation b/w drift velocity and mobility**

$$\mu = \frac{v_d}{E} \quad \mathbf{1}$$

35.  $\text{K.E.} = \frac{1}{2}mv^2 \quad \left[ \because \frac{mv^2}{r} = \frac{KZe^2}{r} \right]$

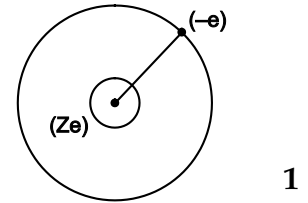

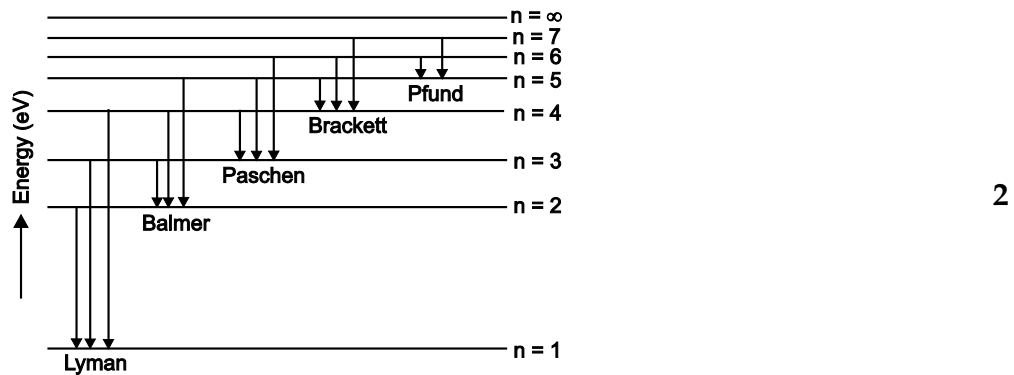
